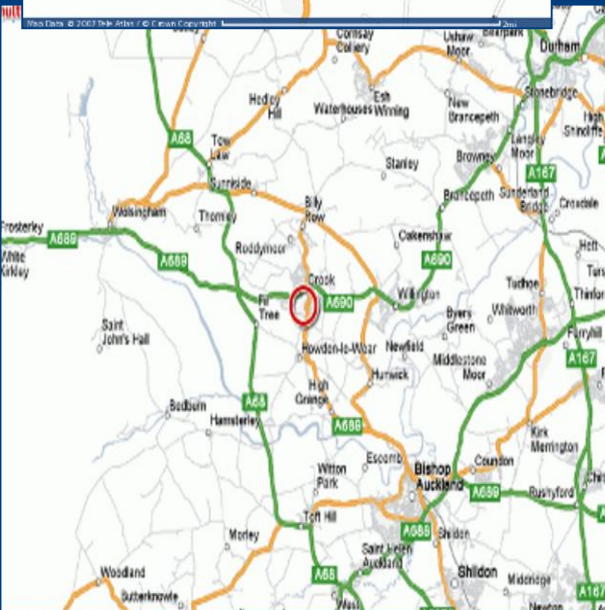

The estate is located to the southern side of Crook town centre and is just off the A689.

Description
