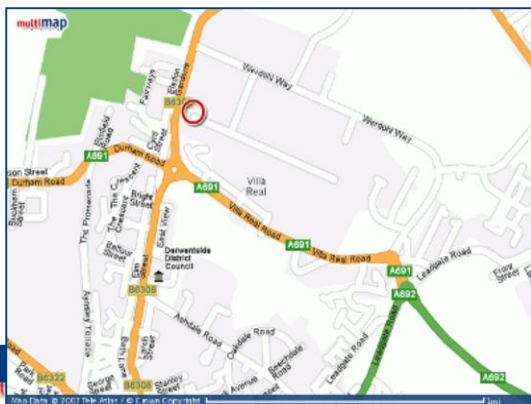

Location

Medomsley Road Workshops are located within the well established Number One Industrial Estate.

The estate can be accessed via the A691 or A692 and is approximately 3/4 mile from Consett town centre.

The estate is 10 miles from Durham City and is 9 miles from the A1/A692 junction at Team Valley.

24 units ranging from 46 - 231 sq m of steel framed construction with brick/block and profiled metal cladding elevations.
