Rowan Trade Park is situated in a prominent position off the main A650 Wakefield Road that links with the Bradford Ring Road and the M606/M62. Bradford City Centre lies one mile to the North, and Leeds is situated approximately 8 miles to the east.

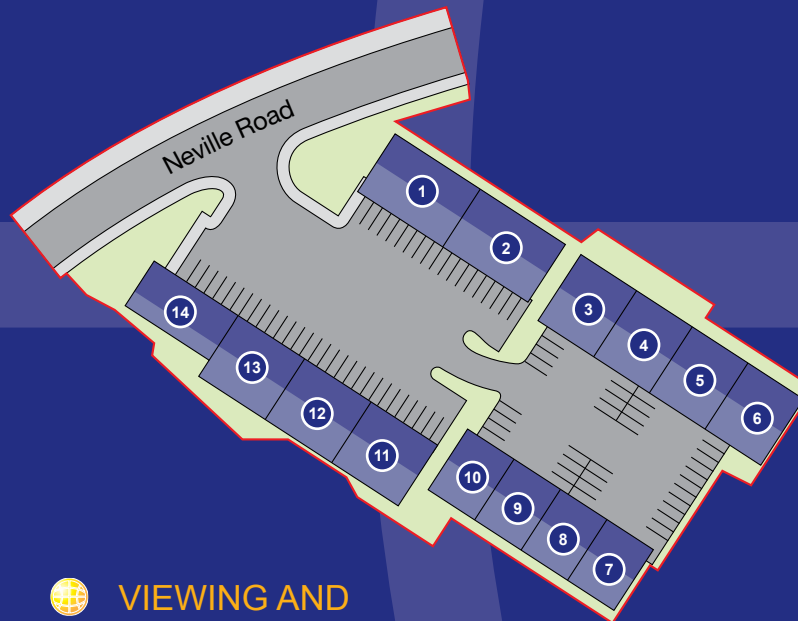
