## WORK STARTED ON NEW DEVELOPMENT AT DINNINGTON!

Northern Trust have announced that following the awarding of £1.025M of Objective 1 Funding, construction has begun at its new industrial development at Redwood Court, Dinnington in Rotherham. The development will provide 15 units ranging from 1,733 sq ft to 23,111 sq ft across a 60,902 sq ft industrial estate that is anticipated to both spur on renaissance in Rotherham and continue to foster the budding entrepreneurial spirit that has emerged in the region.

This sum includes over £730 million of the European Union's Structural Fund budget as well as public and private sector resources. Nick Holmes, Head of Programme Management at Objective 1 continues; "The Redwood Court development at Dinnington will add to the areas growing importance as a major location in Rotherham for new businesses, for employment and as a centre of economic activity. European Structural Funds, such as ERDF, support economic regeneration in areas such as Dinnington where colliery closures had such a marked effect. European funds help with much needed investment that can often make the difference between a project proceeding or not. I am sure that this development will make a positive contribute to the renaissance of the local economy."
