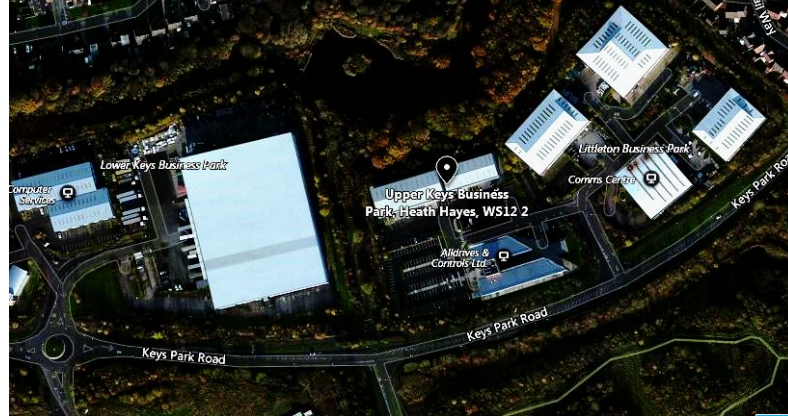

LOCATION

Keys Business Village is located in Hednesford, Staffordshire approximately 1.1 miles to the North of Cannock town centre. The property is accessed off Keys Park Road, which adjoins the B4154 and in turn the A460, leading to junction 11 of the M6, 4.3 miles to the South. The A460 provides access to T7 of the M6 Toll 3.1 miles to the South.

The property benefits from good nearby amenities with Hednesford town centre and train station only 1 mile away also with a large Tesco superstore. Cannock Designer Outlet Centre, an exciting new retail and leisure destination is currently being built approximately 1 mile from the site.
