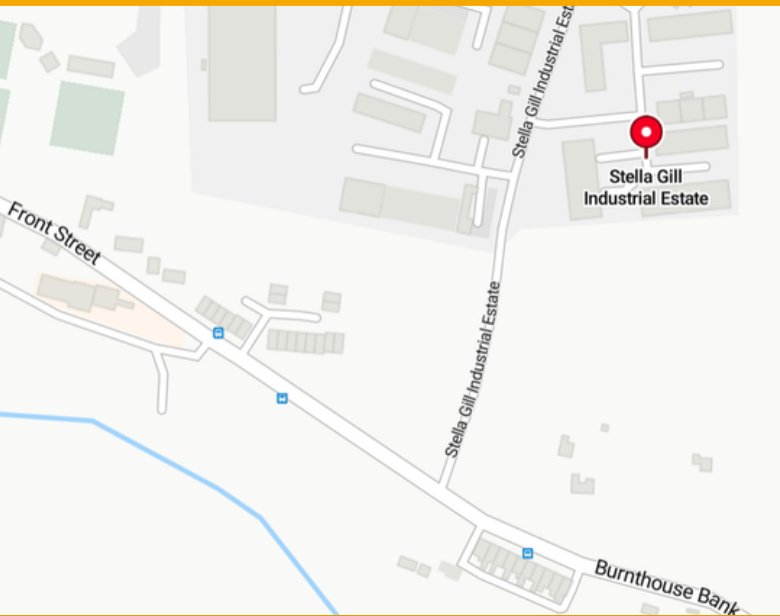

LOCATION

Stella Gill Industrial Estate is situated on Newcastle Road in Pelton Fell, just ½ mile from Chester le Street town centre. The estate enjoys excellent connectivity, being 2 miles approx from J.63 of the A1(M), providing quick access to the regional road network and major cities. Newcastle upon Tyne is approx 10 miles to the north, with Durham around 8 miles to the south, making this an ideal base for businesses seeking strong transport links and proximity to local amenities.
