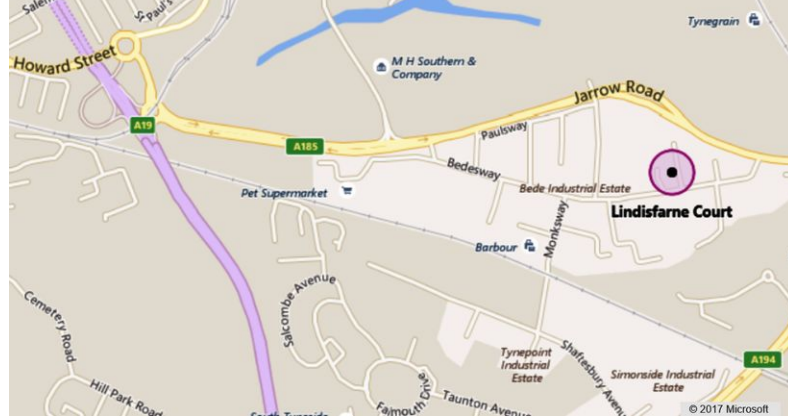
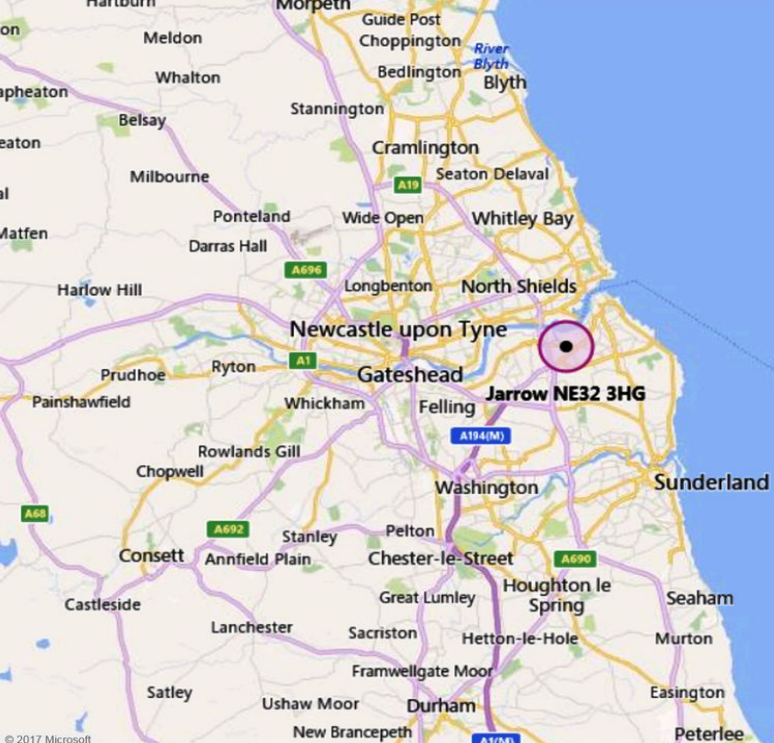

LOCATION

Lindisfarne Court forms part of the well established Bede Industrial Estate and is situated on the A185 road into South Shields, approximately half a mile from the Tyne Tunnel. The A19 and A194 linking to the A1 is only minutes away.

Five terraces of single storey workshop units ranging in size from 495 - 2,421 sq ft. There is security fencing with tenant controlled access gates.
